

Terms and Conditions of Competition – Twitter and Facebook Book Giveaway – 23rd to 25th November 2011

Competition running between 23rd to 25th of November 2011

1. The Promotion is open to residents of Ireland only who are aged 18 years or over, except employees of Bord Gáis Eireann and their families and its subsidiary companies, their agencies and anyone professionally connected with this Promotion.
