## MOVING HOME

If you wish to cancel your gas supply contract you must give us seven days notice in writing or call us on: 1850 632 632

You must also supply us with:

- a final meter reading
- a forwarding address for your final bill
- the name of the incoming occupant, their contact number and previous address, to avoid interruption of supply.

If you cannot provide this you must provide us with access so that we can lock the meter. A connection fee of €140.16 will apply to the incoming occupant to unlock the meter. Please note that you will remain liable for the gas consumed until such notification is supplied to us, and where necessary, access is provided to lock the meter.

## CARBON TAX

The 2010 Finance Bill introduced a carbon tax to be applied to mineral oils, natural gas and solid fuels supplied for combustion in Ireland. The tax for natural gas is derived from the rate of €15 per tonne of Carbon Dioxide (CO<sub>2</sub>) emitted and is to be applied to your gas bill effective 1st May 2010 at a rate of 0.307cent/kWh. Gas supply may be withdrawn if your account is overdue. Reconnection of supply requires a validated declaration of conformance. Fees which will be incurred, should supply be withdrawn are as follow:

Meter disconnection: €159.07 inc VAT  
No access or no safety cert on site €54.85 inc VAT  
Late cancellation fee €21.94 inc VAT
